**The Candlewood Lake Authority is seeking candidates for the position of "Marine Patrol Officer" for the 2023 season.**

- The Marine patrol officer performs daily patrol of Candlewood Lake.
- Responds to calls for service, performs preliminary investigations of accidents, conducts vessel safety inspections, and renders aid to people injured or in distress.
- Position enforces boating laws and any additional powers granted per the Memorandum of Agreement (MOA) between the Department of Energy and Environmental Protection (DEEP) and Candlewood Lake Authority for delegation of boating law enforcement authority, while educating the public on boating and waterway safety.
- The Lake Patrol Officer is responsible for boater education and safety, may be involved in search and rescue and collaboration with other emergency and community services: 7 fire departments, EMS services, local Police Departments, State Police, ECON Police and community outreach.
- Candidates will be required to attend a 40-hour training course over a 9-week period (Candidates will not be paid for training)
- Candidates for employment will be required to successfully complete a swim test
- Candidates must be physically fit and will be required to have medical attestation form signed by a physician
- Candidates must attend all training (dates for training are not flexible)
- Training dates TBD. Winter and spring of 2023
- Candidates successfully completing the training program will be appointed as Lake Patrol officers by the Commissioner of the DEEP and hired by the Candlewood Lake Authority
